### 1. PROGRAMMES OFFERED:

<b>BASLP</b>	A pass in 10+2 / H.Sc., (or) its equivalent examination with Physics , Chemistry and any one of the subject of Biology (Botany / Zoology) / Mathematics/ Computer Science / Electronics / Psychology /Statistics and obtained minimum aggregate marks 50%.
<b>AGE LIMIT:</b> Candidates shall not be older than 25 Years as on 1 <sup>st</sup> July 2025.	

### 2. ONLINE FILLING OF APPLICATION FORM:

- Application forms are available online mode only. It should be filled up carefully by the candidates with complete details and submitted online along with scanned copy of Mark Sheet(s), Photograph & Signature as attachments.

- b) Information provided by the candidates in their online application form, like Name of the Candidate, Contact details, Address details, Details of Parent/Guardian, Category / Community, Educational Qualification details, Date of Birth, Gender etc. will be treated as final and self-certified. The information is non-editable after submission. Any request for change in these particulars will not be considered by VMRF-DU. Hence, ensure all the information entered in the application is true and correct before submission.
- c) During online registration, all candidates, should upload the H.Sc. Mark Sheet(s) on or before 23.05.2025
- d) All the Admission related communications like Rank and Counseling Intimation letter etc., will be sent through Application Portal only. Hence, the candidates are advised to keep their application number for their future reference. No separate communication will be sent to any individual E-mail or SMS
- e) Incomplete online application form will not be accepted.

### **3. ELIGIBILITY FOR COUNSELING:**

The following candidates are eligible to apply for the Counseling conducted by VMRF-DU,

- a) Candidates who have studied in a recognized School and passed H.S.C.Examination (**Academic Stream of 10+2**) of any State Board / CBSE / ISCE (or) any other examination recognized as equivalent thereto, with the group of subjects specified and obtained the minimum eligible marks prescribed by the statutory council concerned/Deemed University;
- b) Candidates who are appearing for HSC (10+2) or equivalent examination in March– April 2025 session and such of those candidates whose results are to be declared by the respective State/ Central Boards

### **4. ELIGIBILITY CERTIFICATE:**

Candidates who have passed qualifying examination other than H.Sc., (10+2) (Academic Stream) Examination of Tamil Nadu, Board of Higher Secondary

Education / CBSE should obtain Eligibility Certificate from Vinayaka Mission's Research Foundation (Deemed to be University), Salem and produce the same at the time of admission.

#### **5. COUNSELING CALL LETTER:**

- a) Counseling Call Letter can be downloaded by all eligible candidates from the Application Portal of this Deemed University from **26.05.2025** onwards.
- b) Counseling call letter must be produced at the time of Counseling without fail. No candidate shall be allowed to attend the counseling without the call letter.
- c) Mere acceptance of a person as a candidate for counseling shall not confer on him/her any right/eligibility for admission. The name of the candidate who does not satisfy the prescribed eligibility criteria shall not be considered for admission

#### **6. COUNSELING CENTRE:**

The Counseling will be conducted at **Vinayaka Mission's Research Foundation (Deemed to be University), Ariyanoor, Salem- 636 308**. The candidates have to appear for the Counseling at their own expenses.

#### **7. MODE OF SELECTION:**

- a) Admission made on the basis of marks obtained in the qualifying examination and merit based Counseling will be conducted by the Admission Monitoring Committee (AMC) of VMRF-DU and eligibility criteria prescribed by the Pharmacy Council of India, New Delhi and VMRF DU rules & regulations.

07. Copy of Aadhaar Card of the Candidate.
08. Copy of Aadhaar Card of the Parents / Guardian
09. Medical Certificate for Physical Fitness

#### **9. ANTI-RAGGING MEASURES:**

- b) All students and parent will be required to furnish a written declaration agreeing to the above said conditions at the time of admission.

#### **11 IMPORTANT NOTES:**

- a) All admissions are subject to fulfillment of all the prescribed eligibility conditions by the candidate. If it is found either at the time of admission (or) at a later stage, that the candidate has given false information/forged certificates (or) concealed material information, his/her admission shall be cancelled and the student shall be dismissed from the college immediately.
- b) The Fee refund policy / timeline is followed as per the UGC guidelines.
- c) The VMRF(Deemed to be University) reserves the all right to change the curriculum, course structure, rules and regulations relating to admission, examinations, fee structure, refund, etc.

- d) Students will be governed by the University rules including refund of fee, disciplinary rules, hostel rules.
- e) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.
